
The Mandal Educational Officer, Vijayawada Rural Mandal has caused inspection and submitted report in the reference 5<sup>th</sup> cited above.

After careful examination of the proposals received from the society and also inspection report of the inspecting officer i.e. Mandal Educational Officer, Vijayawada Rural Mandal here by accords renewal of recognition for I to V classes to Delhi Public School, Nidamanuru, Vijayawada Rural Mandal, Krishna District from the academic Year 2018-2019 to2027-2028 without aid subject to the following conditions:

4. the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
5. that the qualified staff within the age limits prescribed by the Government for Govt Employees shall be appointed as per the staff pattern.
6. that the results of the institution shall be satisfactory every year.
7. that the records/accounts shall be furnished to the District Educational Officer every year by July at the latest.
8. that the list of Governing Body shall be furnished to the District Educational Officer every year.
9. that the pay structure/fee structure fixed by the Governing body shall be get approved by the District Educational Officer every year.
10. that all the conditions prescribed in the G.O.s and other orders which are not specified in this orders shall be complied with.
11. that the school shall not be closed without giving notice both to the parents/District Educational Officer and competent authority at least 6 months before.
12. that the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. that the society shall be submit proposals for Renewal of Recognition on or before 6 months prior to the date of expiry of the renewal.
14. that the management of the school maintained fire extinguishers sufficiently in the school premises.

Previously Provisional Recognition was granted in Delhi Public School, Nidamanuru,Vijayawada Rural, Krishna District to the Classes VI to-X EM from 2008-09 to 2017-18 vide Procs.Rc.No.2332/B2/2008. Dated 17.07.2009 of the Regional Joint Director of School Education, Kakinada.

The Correspondent has submitted the application for Renewal of Recognition classes VI to X EM for the academic years from 2018-19 to 2027-28 in the reference 5<sup>th</sup> cited.

The District Educational Officer, Krishna, Machilipatnam. has verified the application for Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994 recommended from 2018-19 to 2027-28.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada who is the competent authority for Secondary Schools hereby grants Renewal of Recognition for the classes VI to X EM for 10 years from the academic years from 2018-19 to 2027-28 in Delhi Public School, Nidamanuru,Vijayawada Rural, Krishna District under the management of PHR Invent Educational Society, Vijayawada Vide (Regd.No.595 of 2004 Dated 19.11.2004) without Grant in aid now or in future and subject to fulfillment of the following conditions.

2. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
5. That the results of institution shall be satisfactory every year
6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Ednl. Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with
10. That the school shall not be closed without giving notice both to the parents/DEO & competent authority at least 6 months before
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
16. Proper and adequate safety measures shall be taken for children within the school campus and



17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
19. The school shall have first aid kit and the teachers shall be trained in first aid.
20. The Correspondent of the concerned school is hereby informed to file an affidavit before 30<sup>th</sup> of April every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail to the inspecting officer.
22. That the management shall ensure the Accounts of the school audited by an authorized Chartered Accountant every year and submit the same to this office along with Annual Administration Report without fail.
23. That the management has to maintain trained teachers at all time.
24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
25. That the Management is informed to obtain and submit the NOC issued by the Fire Services Dept authorities concerned from time to time without any interruption to the recognition period without fail to the Inspecting officer
26. To follow the rules and regulations prescribed in Circular Memo No. 21748/D1/97, Dt: 16.02.1998 and other orders of Transport authority regarding maintenance of school vehicles/maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport Authorities as prescribed by the Government from time to time.
27. The preventive measures regarding maintenance of school vehicles/maintenance of vehicles to ensure safety of children as instructed in Pr..Rc.No.276/PS-1/2014-2, Dated.19.06.2015 of the C.S.E., AP, Hyderabad should be followed.
28. Take requisite steps to enlighten all the teachers in the School about the Prohibition of Corporal Punishment in Schools
29. Have adequate personnel to guide the movement of the children to ensure road safety and transportation.
30. The Recognition now accorded is subject to confirmation of genuineness of the Fire NOC issued by the fire authorities.
